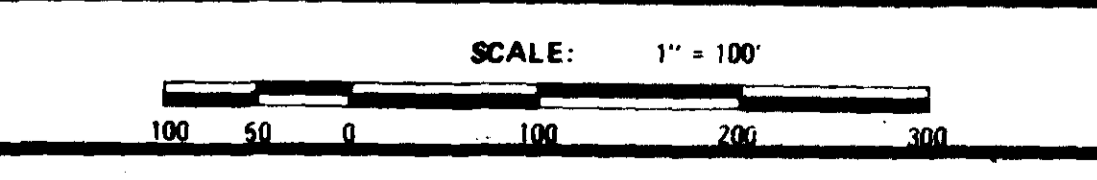
MAP NO 2 - SECTION ONE
